A price list must be displayed at your booth site during the festival.
- * Upon acceptance to the festival be sure to read all vendor information in your vendor packet. You must be checked in by the time stated in your packet or you will not be allowed to set up. You are not allowed to drive through the festival during hours of operation under any circumstance.
